The Christophe Rocancourt Affair **A Television Nine Episode Series** **Writer's Guild of Canada Registration Number S02-6130**

“The Christophe Rocancourt Affair” is an original television nine screenplay series based upon actual true life events substantiated by personal interviews, news accounts, (banned publication) police investigative reports, and Crown transcripts from actual Canadian court proceedings for the reconstruction of those based on true life events.

The screenplay episodes are divided into an nine part series that begins (**Pilot Episode 1 – Flight**) with his arrival in Los Angeles from Paris where he meets an French expatriate who introduces him to Hollywood and the Stars. He marries a former Playboy Bunny Pia Reyes when he swindles the Rich and Famous by pretending to be relatives of very famous people offering great returns for investments. His misadventures catch up with him when a body guard contacts the police that begin a secret investigation and police interviews with some of his victims. His schemes come to an end when Rocancourt seeks safety in an L.A. police station in fear of his life after a street shooting. Los Angeles Investigator George Mueller is contacted and Mueller exercises an arrest warrant that leads to Rocancourt remaining in custody and going to jail. After three months, his wife comes up with the bail money. He absconds with his wife and child to East Hampton, New York.

Starting fresh, in New York, (**Episode 2 – The Fake Rockefeller**) Christophe Rocancourt who is with his wife and infant son takes on a new identity, Christophe Rockefeller and joins a prestigious East Hampton Fitness Center where word gets out that he is part of the Rockefeller family. Again he offers his new victims huge sums of money for cash investments. However, one potential victim doesn't belief him and takes it upon himself to check the fake Rockefeller out. He contacts the police with the evidence that's gathered and the police arrest Christophe Rocancourt during a stake out. This time around he gives the police a fake passport identifying him as Fabien Ortuna. His wife Pia rushes to secure counsel and bail for the misdemeanor charges before Rocancourt's true identity is found out. He is released before a more thorough background check is secured on a national and international level. Within hours Rocancourt, his wife and infant son are on their way back to Los Angeles where they have secured travel to Canada in a private vehicle.

After arriving In Canada (**Episodes 3 and 4 – The Swindle Parts 1 and 2**) after fleeing prosecution in the United States this series shows how he begins setting up his Canadian victims with his charming ability to infiltrated the higher classes of Canadian society utilizing simplistic deceit of being wealthy himself and offering huge financial returns where he feeds on many gullible people who are lured by having foolish thoughts of grandeur and fast cash interwoven with his blatant manipulations of these people's vulnerability to take their money. His obvious manipulations go unchallenged by his victims who become so blinded by their greed to his observable misrepresentations. And, during his swindles, it is revealed how he maintains the “high life” of high priced liquors, call girls, and drugs, using his victim's money, while at the same time keeping his son and his common law wife, the former Playboy bunny, Pia Reyes, nearby him at all times, His victims are unaware of Christophe's real intent to defraud them of whatever he can mastermind. The Swindle is divided into two parts.

The audience is entertained by the events that result in his capture (**Episode 5 – The Capture**), when the Crown alliance in association with unprecedented and most probably the

application of highly illegal long arm of legal tactics provided by L.A. interference (George Mueller) as they set out to capture Christophe Rocancourt which created highly bizarre allegations that leads to his arrest.

Canadian Defense lawyer Mayland McKimm (**in Episode 6 – Preparing a Defense**) has received Discovery from the Crown that could be construed as manufactured evidence, including U.S. interference into the Canadian case by secretly contacting an alleged Canadian victim. McKimm gather's his defensive evidence and prepares his strategy to defend and confront all legal issues on behalf of Christophe Rocancourt.

And, finally the Christophe Rocancourt Series as portrayed in Rocancourt's Canadian defense, (**Episodes 7, 8, & 9 - The Canadian Defense Parts 1, 2, and 3**) shows the Crown's and U.S. government uncanny formulas for detaining and prosecuting Mr. Rocancourt are depicted for the ultimate extradition to the U.S. Amazingly, the star of the series focuses on how his lawyer Mayland McKimm unravels and overcomes insurmountable obstacles of government prejudice and governmental witness deceit to secure a more than fair international deal for his client, Christophe Rocancourt.

On their behalf, Mayland McKimm's décor, expertise and brilliantly executed defense by confronting the convoluted and contradictory issues under which the Crown was holding Christophe Rocancourt, in a "head on" and "no holds barred" legal confrontation that the Crown was using in order to assure their American counter-parts extradition to the United States is nothing short of an astonishing masterpiece performance of brilliant legal representation in the Canadian courtrooms.

Christophe Rocancourt and his wife Pia Reyes story now unfolds as these two have secured most probably one of the greatest legal minds in Canada if not North America for their defenses by hiring Canadian Defense Counsel Mayland McKimm who has the credentials to practice law in both Canada and the United States.
